Geo Chem Afghanistan, part of the global Geo Chem network, is a market leader in fuel and chemical inspection, environmental testing, calibration, and quality assurance. Geo Chem works closely with the Afghanistan National Standards Authority (ANSA) to monitor and regulate the quality of imported petroleum products, ensuring public safety and environmental protection. Through its technical expertise and rigorous quality protocols, Geo Chem plays a critical regulatory role in maintaining fuel standards nationwide.

OUR PROJECTS



Ghoryan Iron Ore Mining Project – Herat Province

Sahil Middle East Logistics is leading a major mining initiative in the Ghoryan district, Herat Province (Second Block), with an estimated investment of USD 861 million over a 30-year period. This project involves large-scale iron ore extraction and processing, contributing to Afghanistan's industrial growth and mineral independence. As the principal operator, Sahil Middle East will oversee all phases of the project, from exploration to production and export. Additional mining operations under Sahil's leadership include ongoing salt and gypsum extraction projects, further diversifying the country's natural resource economy.

National Vehicle Registration & Traffic System – Red Star Refine

Red Star Refine Technical Services has secured a 5-year nationwide project to implement a modern traffic and vehicle registration system. This includes the full development of custom software to electronically register vehicles and their owners, regulate traffic policies, and manage vehicle renewals and mandatory inspections (MOT). As part of this digital transformation, Red Star is working closely with public authorities to bring transparency, accountability, and structure to Afghanistan's transportation infrastructure.

National Customs Scanner Project – Sayas Group

Sayas Group is executing a 15-year public-private partnership project with an initial investment of USD 113 million to install advanced X-ray scanner systems across all key customs border points in Afghanistan. These scanners will enhance national security, increase transparency in trade operations, and help prevent the import of unauthorized or substandard goods. This strategic initiative plays a critical role in strengthening Afghanistan's border control, customs compliance, and national infrastructure resilience.
